### President's Message

It is the beginning of a new year and a new decade. It is time to look forward to new experiences and to bring back those that served us well in the past. And that is what we want to do at the Florida Watercolor Society Convention and Exhibition this year.

The 49th Annual Exhibition will be at the Leepa-Rattner Museum of Art in Tarpon Springs, September 19th to November 29th. This year the exhibition will be open to unglazed, varnished works of art and to deep cradled works. These are some of the changes you can expect in the exhibition and in the annual convention this year. So read the prospectus carefully when it is posted on the FWS website. The opening reception will be Friday, September 25th at the Leepa-Rattner. Bus transportation will be available from the hotel.

The 2020 Convention and Trade Show will be September 24th to 27th at the Hilton Bayfront Hotel in St. Petersburg. You will be in the heart of the newly vibrant St. Pete downtown near the Dali Museum and within walking distance of several new museums and the newly constructed St. Petersburg Pier. Look for demonstrations and presentations on new materials and methods as well as new types of presentations. Some oldies but goodies you can expect to see at this year's convention will be the Lucy's Booth where you can get 5 cents worth of advice on painting from experienced artists and the Meet and Greet message center and gathering post for artists from the different regions of the state. Don't miss the Awards Gala. Last year FWS raised nearly \$28,000 in awards. This year's entertainment will be very different.

And this year's trade show will be bigger than ever. Look for more and new vendors, more demonstrations and other surprises.

Prior to the convention there will be two 4-day workshops and two 1-day workshops. Exhibition Judge and Juror will be Michael Reardon. California native Michael Reardon is a Signature Member of AWS, NWS, Watercolor West, and the California Watercolor Society. Trained as an architect at UC Berkeley, he was an architectural illustrator for over 30 years. Michael and his work have been featured in numerous articles over the last few years, including *Watercolor Artist*, *Watercolor*, *Plein Air*, and the *Art of Watercolour*.

Continued from page 1 Among the things that Michael is known for are his unusual formats and compositions.

Per Michael: "I'm a strong advocate of 'less is more' in composition. For example, when painting a building, I usually crop some of it, rarely showing an entire building. I also use thumbnail sketches before starting a painting in order to reduce the scene to its essential elements, those that tell the story. I find that this allows the imagination of the viewer to fill in the rest, eliciting a more engaging image. In this workshop we will look at ways to simplify compositions and strengthen the impact of your paintings."

In 2017, he received the Ogden & Mary Pleissner Award from the American Watercolor Society. In 2005, he was the recipient of the prestigious Gabriel Prize from the Western European Architecture Foundation, which enabled him to spend three months painting in Paris. Originally trained as an architect with a degree in architecture from UC Berkeley, he was an architectural illustrator for over thirty years. In 2004, he was awarded the Hugh Ferriss Memorial Prize, the premier award in the field of architectural illustration. He is also the author of Watercolor Techniques: Painting Light and Color in Landscapes and Cityscapes from North Light Books.

The second 4-day workshop will be taught by Sandy Maudlin. Sandy Maudlin has been teaching watermedia for over 30 years and has taught workshops throughout the country and in Europe. She holds a bachelor's degree in Art Education from Indiana University and is a Signature Member of both Watercolor Society of Indiana and Ohio Watercolor Society. Sandy has won numerous awards and Best of Shows. Besides teaching, she has also juried and judged art shows throughout the country. She presently facilitates four weekly open studio sessions in her Indiana studio near Cincinnati, Ohio, where she and her husband reside.

Sandy is a vivacious and personable instructor.

She is a repeat and popular instructor at the Kanuga Watermedia Workshops. Several FWS members have taken her workshops in the past and praise the creativity of her methods. Sandy has developed a unique process that she calls "Tape Batik" and has adapted her technique to use on Yupo. While Yupo is her favorite surface to paint on, she continues to enjoy exploring and discovering the new possibilities that being an artist offers. She's very thankful that God has blessed her with the gifts of art and teaching. Enjoy painting, splashing, misting, squirting colors together to make a background for your painting. FWS members who have taken her workshops have loved them. She has been invited back to Kanuga Watermedia Workshops in 2020 for a much-requested encore appearance.

One-day workshops will be presented by both John Bayalis and Dana Daydodge. John Bayalis is a rising star in American watercolor. Noted for his distinct, realistic style, John's use of vibrant color and contemporary themes have earned him awards and recognition throughout the United States. He was featured in the February 2019 of Watercolor Artist Magazine and received the Mary Ann Hollars Memorial Award in the 2019 Exhibition.

Dana Daydodge will be the second one-day orkshop instructor. Her semi-abstract style and experimental techniques have won her awards throughout Florida. She creates unique paintings using her "doodles" and fractured techniques. Bring your failed paintings, paints and watercolor pencils and learn how to turn them from "Failed to Fabulous." Dana will provide the casein and any unique materials needed to revive your paintings.

Make sure your log-in information to get into our member area of the web site is up to date, for you to register for workshops and the Convention. Please make sure your emails are current in your member profile, so that you receive all the important timelines and dates for all the happenings in our Newsletters and email blasts! Spaces will go fast, and you don't want to miss out on anything.

We have an exciting year ahead with new opportunities, new things to learn and new experiences. So, get ready. And follow the advice of Salvador Dali, Painter, paint!




## 2020 FOUR-DAY WORKSHOPS



### Michael Reardon, AWS, NWS

California native Michael Reardon has been painting in watercolor for over thirty years. He is a Signature Member of AWS, NWS, Watercolor West, and the California Watercolor Association. An avid traveler, he uses watercolor to record his observations, convey a sense of place and light, and communicate his impressions of the built, natural and imagined worlds. In 2017, he received the Ogden & Mary Pleissner Award from the American Watercolor Society. In 2005, he

was the recipient of the prestigious Gabriel Prize from the Western European Architecture Foundation, enabling him to spend three months painting in Paris. Michael and his work have been featured in numerous articles over the last few years, including *Watercolor Artist, Plein Air Magazine, and the Art of Watercolour.* Michael will share information from his book, *Watercolor Techniques*. He will share some of his insights into painting and how to enjoy it. Through demonstrations and hands-on painting, Michael will show ways to simplify and create dynamic compositions, work quickly and decisively, and capture the essence of a scene convincingly. He will cover the use of a limited palette, dynamic color mixing, and the use of light and value to describe form. Michael is known for his unusual formats and compositions.






## Sandy Maudlin


Beginning artists will be able to create their own beautiful works of art using Sandy Maudlin's "tape" batik process, and more experienced artists will love the unique textures and surprises of color that result from "tape" batik. And for this workshop, you CAN paint, even if you don't know how to draw. Using transparent watercolors on Arches watercolor paper, along with some

masking tape, each artist in this workshop will develop a one-of-a-kind

painting that will be 'hidden' until the last day. Subject matter to paint is your choice, and Sandy will have several photos with her if you need inspiration. Each day will include well-organized demonstrations of this technique, followed by studio time and lots of individualized attention. An informative critique at the end workshop will help, not only with technique, but also with composition and design of your artwork. With Sandy, paper and Yupo, liquid acrylics, watercolor, watercolor pencils, and just about anything else is fair game as a material to create expressive art. Sandy holds a degree in art education from Indiana University and teaches workshops throughout the country as well as overseas. Her passion is to paint, and she loves to share what she has learned with other aspiring artists.



## 2020 TWO ONE-DAY WORKSHOPS



### John Bayalis,

John Bayalis has been the recipient of numerous awards throughout the United States and has painted abroad in Ireland, England and France. Noted for his distinct, realist style, the artist's skill at handling contemporary themes and subject matter has earned him acclaim from art critics and collectors throughout the United States. John was featured in the Feb. 2019 *Watercolor Artist Magazine*. Among his honors are an award of an individual artist's fellowship grant and the selection for The Watercolor Page in *American Artist Magazine* where one of his works graced the cover.

He paints realistic images of local scenes, both in St. Petersburg, and of other places

he has lived and work. He is also known for his unique still life arrangements featuring unusual viewpoints.




### Dana Mencinskas Daydodge,

Dana has developed several unique approaches to painting, including one she calls Doodle that morphs into finished paintings and a technique she calls Fractured. In this workshop Dana will teach her over-

painting process to turn old paintings into new using casein and



gouache. She will provide the casein, you provide the "failed" paintings and your paints. At the end of the day you will have turned "failed to fabulous." Dana lives in Haines City but is originally from Chicago. She graduated from the American Academy of Art in Chicago where she learned watercolor. She is a Signature Member of the Illinois Watercolor Society, Florida Watercolor Society, Georgia Watercolor Society and the Tallahassee Watercolor Society. Dana is an award-winning artist and popular workshop instructor.

#### I Have to Write a WHAT?!?

**Catching Up with Entry Minutiae & More** with Robin Lee Makowski, FWS Digital Director

### **Happy New Entries Year, Compatriots!**

You may or may not know that your FWS Board meets faceto-face only twice per year: at our annual day-long Board Meeting in January at the hotel where that year's Convention will be, and briefly at the Convention in

September. During these two meetings, and sometimes during the year via digital meeting rooms, your Board does all the work FWS needs to do as a group entity to make sure you have every opportunity to enter our two exhibitions and to attend our Convention & Trade Show where you can scarf-up amazing art supplies and watch live demos by the most prominent watermedia artists in the business. You also have the opportunity to see that year's judge do a demo and an Exhibition Review of all of his or her selected images and award-winners, attend four-day workshops by the Annual and the Online Show Judges, plus two or more one-day workshops by noted locals. Few – if any – other state arts organizations offer as much to their members! And it's a TON of work! 2020 will be exceptional in the beautiful city of St. Petersburg under the watchful eye (and thumb!) of our new FWS President, Terry Denson, who, on a personal note, got yours-truly into this Digital Director position five-plus years ago! She is to blame or to credit as you see fit... I have her address to either send her flowers or hunt her down.

If it's any consolation (or you want to send me flowers!), I fought hard this year to have our very strict framing rules relaxed - and won! The Board was in agreement that our rules were behind-the-times and that we need to catch-up with some of the other organizations. In this year's Prospectus, you will see new rules for presentation of your work and relaxed framing guidelines. Be sure to read your 2020 Prospectus which will be available around the end of March.

We all learn a lot in our Board positions and take to heart all of our Members' issues and concerns. This year, we have a couple of wonderful chair women who are relatively new to the inner workings – Tuni Weiss, who is (thankfully!) Ruby's assistant as Convention Facilitator, and Roberta Romeo, also the 1st Place Winner in our 2020 Online Show (Congrats, Roberta!!), acting as Volunteer Coordinator this year.

At the January meeting, Tuni asked me about writing an Artist's Statement for an entry, about which she had no idea. Rita had just called for articles for the February Newsletter, so it was then decided that was what I would write about, especially considering I had just won the Winslow Homer Award (2nd!) in the FWS 48th Annual with what I thought was a good painting, about which I had composed the best Artist's Statement I had ever written! Did it help? I don't know – that's a question for Carol Carter, who had to read 560+ artists' statements to help her decide where our heads were at when we entered X painting. I am hoping my statement helped!

So, what is an Artist's Statement, anyway? How does that differ from a bio? Valid questions which we have received many times. I will try to help to clear it up for you. Please decide which statement(s) would help you decide whether a painting gets into a show – or not:

#### 1. Bio or Statement?

"I have painted in watercolors for over five years. I took workshops with X Artist and X Artist, and I won an award at the library for my cat painting. I always wanted to try watercolors and since I retired, I had the chance. I now travel a lot and take my own photos for my paintings. I use Cheap Joe's Kilimanjaro paper and Daniel Smith watercolors."

#### 2. Bio or Statement?

(Artist) graduated with a BA at X College and went on to study painting with Big Name Artist in addition to working. After several years in advertising with X Business, (artist) went back to study Graphic Design at X University. Upon completing his/her MA degree, (artist) went onto XX Advertising Firm for fifteen years. Finally realizing what s/he wanted to do the entire time was paint, (artist) quit the corporate world in favor of teaching painting and continuing his/her own career, getting into XYZ Gallery which launched his/her painting career.

#### 3. Bio or Statement?

"She was not aware she was being observed; of her place in this scene; how the multitude of artificial lights threw shadows and shimmers in a million directions, drowning out midnight. She was not aware of the painting she was inspiring while she went about her mundane tasks in anticipation of going home. She was not aware - but I was! Edward Hopper is my favorite artist. This scene with the lone figure getting ready to close the bar made me think of his work and how this scene may be something that would have inspired him, as well. My tribute to Hopper - cheers!"

More questions: Which statements are about the artist? Which statements are about the process? Which statements are about the materials? Which statements are about the artwork?

When you are asked to write an Artist's Statement trying to get into a show, you have to put yourself into the judge's place having to read HUNDREDS of these statements to help to make his or her decisions. We get very lengthy statements that are never read, some of which have nothing to do with the painting that was entered.

An Artist's Statement is about the WORK you are trying to get the judge to recognize. It can be about the inspiration, the process, how the materials were used – NOT about the artist's education, moving up in the ranks, or what awards the artist won. You want to invite the judge inside your head to understand why you entered that particular work. It may be part of a series, or a continuation of a process that was previously successful for you. It may be something you've been striving to accomplish and finally feel you did. These are the kinds of things most judges will be impressed by that will complement your work. This lets the judge know what you were inspired by and why you think you deserve a coveted spot in this show.

Keep your statements to a few sentences that are relevant to the artwork: the process, the inspiration, how you accomplished that particular work. It's fair to make sure you know that during the process, judges in FWS shows see the artists' names. This is necessary because each artist may only have one piece selected to show.

So, if a judge likes both of a certain artist's pieces, a decision has to be made which is in and which is out.

It's also fair to know that the #3 statement was mine for Last Call – watercolor on Aquabord, my one and only entry this year. It described the inspiration for the work and why it was important to me. I'm not sure if it was relevant to Carol, but it was relevant to me to convey what I felt about the painting, and I feel I did that successfully.

Did it help? Will I do it again? You betcha!

Will it help? That remains to be seen... But I will give it my best shot, and I hope you do, too!

## MEMBERSHIP CHAIR NEWS

Hi, I'm Diane Lary, FWS 1st Vice President/Membership Chair.

The Membership Renewal deadline is January 1st each year. If you have not done so already, your membership is overdue. Now is the time to make a New Year's Resolution that's easy to keep by paying your FWS Membership dues in January, especially if you are planning to enter the FWS 2020 Exhibition. Also keep in mind to maintain your Signature, P1 or P2 status, your dues must be current and paid. If you have skipped a year in paying your dues, you have lost your status. You may reinstate your Signature, P1 or P2 status by paying back dues and this year's dues.



Members paying by check must postmark their check by March 31, 2020 to be eligible to enter the 2020 Exhibition. If you are an existing member and paying online the absolute deadline to renew is June 6th, which is also the deadline for the Annual Exhibition. The deadline to renew will be here before you know it, so it's best to JUST DO IT while its fresh in your mind. I recommend that you renew soon, then you can concentrate on painting and making sure your entry for the Annual Exhibition is ready to go; professional photo taken, file is sized properly and you have read the Prospectus carefully. Then when the entry window for the FWS 49th Annual Exhibition opens you are ready to enter the show through CaFÉ. I have found that if you wait until the last minute and have problems, it can be stressful. You can renew online by credit card, or through PayPal. This is a secure, easy and fast way to renew. Just click on RENEW on the FWS website. Then follow the instructions. VERY IMPORTANT: Since our communication to our members is now all done electronically, it is essential that you maintain your profile on the FWS website membership database. Log in with the same email you used to establish your account and make sure your password works and all your profile information is current and up to date. ## CONVENTION TIDBITS

#### Love Those Demos!

The thing that many of us love most about the FWS Convention is the demos. We watch. We listen. We take notes. And then we go home with our heads exploding with ideas. We cannot wait to paint.



When Judy Saltzman (judysaltzman. com) was struck by the natural beauty of a national park in Georgia, she set out to capture the American land-scape in paint. Like many artists before her, Saltzman wondered

before her, Saltzman wondered exactly how to capture such grandeur on paper—and thus, her large-scale, multi-panel works were horn.

"I learned that our national parks face numerous issues, like climate change, invasive species, water usage and funding," says Saltzman. "I was booked, and submitted a proposal for an exhibition, which was accepted." All title while after her fateful trip to Georeis, Saltzman was awarding. A little while after her fateful trip to Georgia, Saltzman was awarded a set of Daniel Smith PrimaTek miner-al-based watercolor paints. "After experimenting and discovering their inherent earthiness," she says, "I knew how to approach these paint-

ings. I loved the fact that they're made from minerals." The paints would be used in all four of Saltzman's paintings—although the number is slightly misleading, as the four paintings are actually comprised of 19 painted panels. "Some are three feet wide and four feet tall," she says. One. an octaytch, measures a full feet wide and four feet tall," she says. One, an octaptych, measures a full 24-feet wide. "It brings viewers to the elevated edge of Bryce Canyon's Cassidy Trail, overlooking the crimson-colored Hoodoos, Bristlecone Pine Trees and a small band of horseback riders," explains Saltraman. "We're fortunate, as a country, to have these resources. "Spirit of America' is a tribute to its beauty and grandeur, while honoring the majestic and magical places. I hope this body of work will spur, not only appreciation, but maybe even action."






